WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request.

NOW, THEREFORE, the Governing Body of Western Nebraska Community College resolves that the **2024-2025 property tax request be set at:**

Adoption of Resolution Setting the Property Tax Request (cont.)

The total assessed value of property differs from last year's total assessed value by 7.9 percent.

The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be 0.09167 per \$100 of assessed value.

Western Nebraska Community College proposes to adopt a property tax request that will cause its tax rate to be 0.021121 per \$100 of assessed value.

Based on the proposed property tax request and changes in other revenue, the total operating budget of Western Nebraska Community College will increase (or decrease) last year's budget by 1.25 percent.

Reports and Recommendations from the Board Finance and Facilities Committee WNCC/ESU13 Technology Center Condominium Agreement

Mr. Kelly, College attorney, explained in 2007 WNCC and ESU13 entered an interlocal agreement to co-own specific areas of the John N. Harms Center (HATC). A condominium arrangement was developed, which means parties can own the interior space of a building independently of each other, so the south end of the building is divided into unit one, owned by the College, and unit 2 is owned by ESU13. There is a specific plat and legal description regarding which classrooms, or what spaces are owned by each entity. As part of the interlocal agreement, it is determined how utilities will be paid, how the property will be maintained, and how janitorial services will be provided along with insurance coverage, etc.

With the new project to build the high bay into two floors of classrooms, the condominium description will need to be modified. The interlocal agreement addresses how co-ownership will be managed. The condominium declaration, followed by registered deeds will need to be amended. There will be a change to the interior space and areas WNCC and ESU13 will own, so a replat will be filed. Today, four items will require Board approval.

Workforce and Lifelong Learning Fiscal Year 2024 Update

This report was tabled and will be presented at the October 16, 2024, Regular Board meeting.

Student Report

Standing in for Board Student Representative Mr. Charles Oguoma, Ms. Adelita Calistro shared she is a non-traditional student representative for Cougar Council, the College's student organization. Ms. Calistro mentioned she is enrolled in medical billing and coding courses, and this will be her last year at WNCC. Her time at WNCC has been a wonderful journey, she has met several people and connected with many areas of the College, which helped her assist other students.

Ms. Colistro visited with various departments accessed by students. Library staff were excited to be a part of the orientation tour and set up a scavenger hunt for students coming in so they could see the different areas of the library and resources they offer.

The 2024 WNCC Adult Education program ranked first in the State in performance, which is not an easy task. Since the first of July, four students have graduated with their GED and a large graduating class is expected for the upcoming year. They have also been working to connect immigrant families with free ESL classes.

Faculty Report

Instructor, Ms. Carrie Howton reported this is week five of the semester and faculty have been busy. Ms. Howton mentioned faculty have been impressed with Dr. Lisa Blair, the new Dean of Instruction – Arts and Sciences.

Nebraska Community College Association

Chair Anderson reported the NCCA annual meeting is scheduled November 4th and 5th in Norfolk, NE and registrations are due today. The Board secretary will submit registrations to the NCCA office.

The NCCA Board retreat included discussion of priorities for next year. Top priorities included ARPA funds and dual credit.

Western Nebraska Community College Foundation

In the absence of Ms. Reisig, Foundation Executive Director, Ms. Guzman-Gonzales shared the Foundation report submitted by Ms. Reisig.

As of today, September 18, 2024, 523 runners are registered for the Monument Marathon race, which is 80 more runners than last year at this time. Seventy percent of the registered runners have never participated in the Monument Marathon race. Runners are coming from thirty-six states as well as Kenya and South Korea. The Foundation is on track to raise about \$60,000 to support WNCC students with this event.

Homecoming is scheduled the week of October 21st and events are scheduled on all three campuses. Additional information can be found at https://www.wncc.edu/homecoming.

President Comments

President Dart reported he was in Lincoln last week for a couple of events and was a panelist at the State Chamber of Commerce meeting. The Economic Development Summit was regarding the six region one Nebraska work that is going on across the State. Our region is led by Mr. Owen Palm and Mr. Zach Karpf. Several people throughout the College have also been involved. At a meeting scheduled next week, discussion will be held regarding aligning education and workforce and how to get those moving in the same direction at the same time.

The Coordinating Commission for Post-Secondary Education (CCPE) also met, and the College had two items in front of them. One was the community college budget request, which goes to the Coordinating Commission. Once approved, information goes onto the Legislature and then to the Governor's office.

The second item presented to the CCPE was the College construction trades program. This program has been in the works over several years and last year, a construction trades program was started that included different trades that were offered in Scottsbluff, Sidney, Alliance, and throughout the Panhandle. The program was offered as non-credit while the credit bearing program was being finalized. The credit bearing program is an applied associate degree with four professional skills certificates built in. The professional skill awards are in plumbing, HVAC, carpentry and electrical. Several steps were involved to get a credit bearing program, one of which was approval by the Coordinating Commission. On Friday, CCPE granted unanimous approval of the program. Approval is required from the Higher Learning Commission

then goes to the Department of Education for financial aid approval. President Dart thanked all staff who worked to get to this point.

September is Hispanic Heritage Month, and several activities have been scheduled at the College. In the past, WNCC had a Hispanic advisory committee, and the plan is to restart that committee. Hispanic's are a segment of our population that continues to grow, and enrollment has been over 25% for several semesters.

ARPA funds have assisted with discounting dual credit tuition and the big ask of the legislature is to take those funds and make them permanent so that we can continue to discount tuition. Current discounting is under review. The intention is to offer dual credit to our area high schools at zero dollars. Hopefully, the State will look at making that funding permanent.

The College has a wellness committee that does tremendous work with employees, and they are unbelievably active and offer numerous activities throughout the year. Tomorrow, the committee will be given the Governor's Growers Award in recognition of their work.

At the October meeting, the enrollment audit will be presented. From the ten-day report, WNCC has seen an increase in enrollment. Officially, in total, the College has a head count of a little over 4%, retention increases of 6.3% from spring to the next fall and a 15.6% increase in dual credit. It is great to see all those numbers trending in the right direction, and it is a testament to our faculty, staff and those involved in enrollment management and student success.

Board Member Comments

Chair Anderson congratulated President Dart, Dr. Grant Wilson, and Mr. Doug Mader on the construction trades program that has been in the works a couple of years and stated it is nice to hear that it was approved by the Coordinating Commission.

Chair Anderson thanked Board members for their time at today's meetings. Some may not realize that the Board is present the entire day. Monthly meetings now include an informal meeting before the regular meeting, which allows time for discussion of agenda items and provides onboarding education for new members. Additionally, Board members usually have homework before they arrive. Chair Anderson stressed that their commitment is appreciated.
