Special Hearing to Set Final Tax Request

Chair Klemke asked Ms. Lynne Koski, Vice President of Administrative Services, to present the final tax request information.

Ms. Koski explained that as a part of the budget process and setting the tax levy, two hearings are required. The Budget Hearing was held at the September Board meeting and there was a change this year regarding the requirements related to tax requests. The hearing today is specific to the tax levy and tax request for the community college budgets.

Establishing the College's rate, and property tax requests, includes taking into consideration the levy lid and the tax request limit.

Property Tax Levy Lid – Statutes 77-3442 and 85-1517

The levy must not exceed the difference between 11.25 cents and the rate levied for capital improvement funds per \$100 of taxable property valuation for operating expenditures.

State Statute 85-1517 authorizes property tax levy up to 2 cents per \$100 valuation for fiscal years beginning July 1, 2013, and after, for capital improvement funds.

Total Property Tax Request Limitation – State Statues 77-1631 through 77-1634 (new)

Property tax requests greater than allowable growth percentage (2% plus real growth percentage) requires participation in a Joint Public Hearing.

Proof of Publication

Ms. Koski stated that publication of the Special Hearing to Set Final Tax Request 2022-2023 in the local newspaper is required. The publication contains information for the 2021 budget year and compares it to the proposed year.
