## Types of aid which may be available for summer

## Factors that impact Summer Financial Aid eligibility

- Number of credits enrolled and attending in the summer
- For Federal Direct Loan program the portion of your annual limit that you received during the fall and spring semesters
- The amount of institutional and discretionary grant funds available to award
- Financial need as determined by the 2021-2022 Free Application for Federal Student Aid (FAFSA)
- You must be in an eligible degree, certificate, or diploma program
- You must be making satisfactory academic progress
- You may not be in default on a federal student loan or owe repayment of a federal grant
- You must have a high school diploma or GED
- You must be a U.S. citizen or eligible non-citizen
- You must have a valid Social Security Number
- You must be registered with Selective Service, if required
